CANCELLATION BY PASSENGER

All cancellations must be in writing.

Cancellations up to 6 weeks prior to arrival -10% of the total cost is retained as an administration fee. Cancellations less than 1 week prior to arrival -50% of the total cost is retained as an administration fee. In the event of any cancellation 48hrs or less prior to arrival or in the case of a no show, full cancellation fee will apply.

COVID-19 REASSURANCE

In the event that you do have to cancel attendance due to Covid-19 travel restrictions, then we will hold your fees for an indefinite period without penalty from Banora International Group (BIG) so you can apply it in the future to a holiday in Cairns.
